The admission requirements for study at the Faculty of Economics, Prague University of Economics and Business (hereinafter also referred to as VSE), are determined by the decree on the admission procedure for the Faculty of Economics for the respective academic year. A legal requirement for admission to the master's degree program is the completion of a bachelor's degree program with an economic focus.

The Economics and Public Policy program is a paid program.

An applicant may be admitted to the master's degree program taught in English if they

- a) pass the entrance exam and
- b) provide proof of completion of a bachelor's degree program.

Entrance Exam

The entrance exam will be conducted in English and consists of three parts: creating and submitting a CV, writing an essay, and submitting a motivational video. It is recommended that applicants possess at least an upper-intermediate level of English proficiency.

- The CV must include information about previous studies, relevant work experience, and other relevant activities. The format and structure are not strictly defined. It must be submitted in PDF format.
- The essay topic is not predetermined but should be related to the focus of the study program. The requirement is to create a coherent text on a chosen topic, demonstrating the applicant's ability to express and formulate their thoughts. The specified length is two standard pages.
- In the motivational video, the applicant should present their motivation for study, qualifications, benefits, and strengths. The time limit is set to a maximum of 2 minutes,

and there are no restrictions in terms of creativity. The video should be uploaded to www.youtube.com.

The resume, essay, and the YouTube link to the video must be attached to the electronic application in PDF format.

The admission decision is based on a point evaluation system, with the results of each part of the entrance exam weighted as follows: 25 % for the CV, 35 % for the essay, and 40 % for the motivational video. The applicant can achieve a maximum of 100 points.

Applicants who have completed a bachelor's degree program at the Faculty of Economics VSE and have never been enrolled in a master's program at the Faculty of Economics that they did not complete, may be admitted without taking the entrance exam.

Application for Study

- The application for study in the academic year 2026/2027 can be submitted within three deadlines (including the receipt of payment in the account). The application deadlines are:
 - **by February 28, 2026,**
 - **by April 30, 2026,**

The Dean of the faculty may decide on the organisation of a third round to be held by June 15, 2026.

- The application must be submitted exclusively online at <http://prihlasky.vse.cz>. All required information must be filled in the application (including the applicant's secondary school field of study).
- The fee for admission procedure services is 50 EUR and can be paid either immediately upon submitting the application by credit card or by bank transfer (the account number and variable symbol will be sent to the email address provided in the application). The payment must be received in the VSE account no later than the application deadline (i.e., by February 28, 2026, April 30, 2026, or June 15, 2026, if a third round is held).
- The applicant is considered registered once the fee for admission procedure services has been credited to the VSE account in the correct amount and manner as specified above, and all required information has been fully completed in the application.
- Late changes to the application (after submission and payment deadlines) will not be accepted. If the paid amount is lower (for example, due to a bank handling fee), the applicant will not be considered registered. The fee for admission procedure services is non-refundable.

Verification of Admission Requirements

- An applicant who is not a graduate of VŠE must demonstrate the completion of at least a bachelor's degree by submitting an officially certified copy of their university diploma, or, if the diploma has not yet been issued, a certificate of graduation from the registrar's office of the university they attended.
- Documents required to be submitted with the application (e.g., a copy of the diploma) must be provided exclusively in electronic form, specifically in a digitally signed (converted) version (including a verification clause). The document must first be

converted into electronic format (PDF) at a Czech POINT branch and then uploaded to the application. Simple scans of documents are not accepted.

- If an applicant for admission has obtained foreign higher education by completing a study program at a foreign university, he must demonstrate that he has achieved at least a bachelor's degree in one of the ways specified in Section 48 of the Higher Education Act (a decision on the general recognition of foreign education, a document confirming foreign education as equivalent under international agreements) or through the evaluation of foreign education by VŠE.
- The process of evaluating foreign education is initiated by the faculty to which the applicant has properly submitted their application. Upon submission of the request, the applicant is required to pay the designated fee; if the fee is not paid, the evaluation of foreign education will not be conducted. If the applicant submits multiple applications for study programs, the request for evaluation of foreign education is processed only once, and the evaluation result is valid for all study programs of the same type to which the applicant applies. Payment of the fee and submission of the required documents must be completed well in advance of the enrollment deadline or, as applicable, before the deadline for providing proof of prior education set by the faculty.

Admission Decision

- Applicants who have taken the entrance exam may be admitted if they have achieved at least 70 points. The number of points obtained in the entrance exam can be viewed by the applicant in the VSE Student Information System.

Enrollment in Study

- Enrollment in the study program is conducted continuously online via the e-return form, based on information stored in the applicant's repository. Applicants will enrol online in the Study Information System (InSIS) under the section "[Return Form for the VSE Study Application](#)" after receiving the admission notification and within the deadline set by the faculty dean. **Enrollment must be completed no later than September 11, 2026.**
- Based on a written request submitted no later than on the day of enrollment, the Dean of the faculty may set an individual enrollment date for applicants who are awaiting the recognition of their foreign qualifications (nostrification). The individual enrollment may take place no later than September 12, 2026.
- Applicants will automatically receive an email from InSIS with further necessary details regarding enrollment.
- Once the applicant has received the admission notification and confirmed the e-return form in the Study Information System (InSIS), they will be enrolled in the study program. Subsequently, an InSIS account, including a password, will be created. Both credentials will be available in the applicant's electronic application after logging in.
- All study confirmation documents (with a digital seal) will be available in InSIS after enrollment (Student Portal – Print Documents – Print Digitally Sealed Documents). The

generated document will be stored in the Student Document Repository in InSIS. The procedure for converting the document into a printed format is described in detail [here](#).

All documents related to the admission process are transmitted by VŠE through the InSIS electronic information system.

Applicants are required to submit all application materials to VŠE electronically via InSIS.
